It looks like Heather Carter will be representing Safe Schools at this meeting. The group is convening a 'rapid response network' that can come to the aid of school districts under attack by the right wing for having LGBT-inclusive policies, programs, or curricula. The past several years have seen some school districts back down from inclusive programs, and safe schools advocates routinely encounter fears of a backlash for addressing LGBT issues. In the coming months, we seek to figure out how our already-existing networks and resources can be mobilized at the right time to provide the support these districts need to continue creating inclusive and welcoming environments for all students and families.

#### (5) LAW & POLICY WORK GROUP REPORT – Josh, Lonnie, Beth

Hearing on HB 2015, which would enhance anti-harassment efforts in schools, went well – We helped identify folks from the disability community to testify and Beth testified that SSC hears from students and families who do not know where to turn for help with bullying.

HB 1612/ SB 5629, the “Proven Programs Act,” which would allow state agencies to seek funding for only those pregnancy prevention programs that are medically and scientifically accurate and evidence-based... is now supported by PP, NARAL, ACLU, NOW, Public Health – Seattle & King County and the NW Women's Law Center. Right now, states must seek funding for all pregnancy prevention programs, even those that have not proven beneficial

c) Other bills that may be of interest to our members:

- HB 1643 Regarding harassment, intimidation, and bullying policies and practices at regional universities
- HB 1193 Creating a program to allow youth to preregister to vote
- The domestic partnership measures are Senate Bill 5688 and House Bill 1727.
- The marriage bill is Senate Bill 5674.
- **A Federal Employment Non-Discrimination Act (or “ENDA”) has NOT been introduced yet.** Now would be the time – with Congress newly sworn in -- to let your congressperson and senators know how you feel about the inclusion or exclusion of protection for the transgender community.
- Foster care related bill:
- Foster care to 21 (HB 1961), Independent Youth Housing Program (HB 1492), Notification Rights for Youth in Foster Care (SB 5758), Legal Representation for Foster Youth 12 and Older (HB 1183 & SB 5609)
- The WEA opposes The Basic Funding Bill (HB 1410 & SB 5444) because it has no funding attached to it.

#### (6) MEMBERSHIP REPORT – Gabi

New member applications: **Queer-Straight Alliance at the University of Washington Tacoma- WELCOME!** A unanimous vote! They have been experiencing multiple issues on campus: they're the only queer focused group, issues with marginalization of GLBTQ students, double booked w/other events, one student complained that there wasn't enough GLBT focused classes and the response was “We have that class on AIDS”.
