(1) SHARING TIME:

- a) Chris Johnson reported that the Children's Response Center at Harborview Hospital is involved in a Public Health – Seattle & King County team that is writing sexual violence prevention lessons for a 2nd edition of the **Middle School FLASH** (Family Life and Sexual Health) Curriculum. Beth Reis is on a team writing other lessons for the new **Middle School FLASH**.
- b) Gabi Clayton informed the group that Youth Guardian Services has a new Executive Director in Australia and a new Assistant Executive Director from Jamaica. Youth Guardian Services is a youth-run non-profit organization that provides three YOUTH email support lists for GLBTQ youth ages 13-17, 17-21 & 21-25, heterosexual ally youth and LGBTQ youth with eating disorders. www.youth-guard.org

(3) HEALTHY YOUTH SURVEY – Beth

- a) One of the questions about sexual health that SSC worked so hard to get included in the survey – the one about genders of partners -- was omitted in the final draft administered fall 2010. Because of a funding glitch, the fall 2012 survey has already been printed.
- b) The Coalition has decided to form an ad hoc community organizing committee to coordinate a statewide effort to offer to the Department of Health to reach out to the schools that opted out of the survey in the past based on the questions of sexuality (or other reasons) to educate them on the importance of opting in and the inclusion of such questions. **HELP NEEDED (great project for an undergraduate or graduate student in public health or health education): We need someone willing to convene such a committee.** Beth Reis, Mo Lewis and Matthew Wilson said they would be willing to serve on the committee if someone is willing to be the convener.
